POSITION OVERVIEW:

The Asian American Advocacy Fund (AAAF) is seeking **PHONEBANKERS** to join our team for the upcoming 2024 Elections in Georgia. Phonebankers for AAAF will focus on engaging Asian Americans and other previously underrepresented communities in Georgia.

Applicants must be authorized to work for ANY employer in the United States. We are unable to sponsor or take over sponsorship of an employment Visa at this time.

Responsibilities:

Community Engagement:

• Phonebankers are expected to actively engage with members of the local community to encourage civic participation and provide information related to AAAF campaigns and projects, primarily through direct phone calls and text messages.

Data Entry

• Phonebankers are expected to maintain accurate, current, and detailed data relating to individual community engagements and entering the collected information into our databases.

QUALIFICATIONS OF THE IDEAL CANDIDATE

The ideal candidate for this position is a dynamic individual who is passionate about political organizing and community outreach, with a demonstrated commitment to advancing social justice causes. As a representative of AAAF within the AAPI community, they should be personable and able to build strong relationships with community members, while possessing exceptional communication skills.

Must Haves:

- Phonebankers must display values alignment with the mission of AAAF
- Phonebankers must be comfortable interacting with unfamiliar community members over the phone for extended periods of time

- 4. This position requires access to a mobile phone that you can use for work, can you confirm that you have this?
- 5. Do you speak any other languages besides English, what level would you say is your language capacity in that language? Would you be able to hold a political conversation in that language? Are you able to read/write in that language?
